No. 10/27/08-AS6/809 .- In exercise of the powers conferred by section 7 (1) of the Punjab Industrial Facilitation Act, 2005 (Punjab Act No. 23 of 2005), and all other powers enabling him in this behalf, the Governor of Punjab is pleased to constitute a 'State Board' for Industrial Facilitation in the State comprising of the following members: -

(a) Chief Minister, Punjab	: Chairman
(b) Industries & Commerce Minister, Punjab	: Vice Chairman
(c) Local Government Minister, Punjab	: Member
(d) Housing and Urban Development Minister, Punjab	: Member
(e) Finance Minister, Punjab	: Member
(f) Power Minister, Punjab	: Member
(g) Labour and Employment Minister, Punjab	: Member
(h) Science, Technology and Environment Minister, Punjab	: Member
(i) Forests Minister, Punjab,	: Member
(j) Public Works (B&R), Minister, Punjab	: Member
(k) Excise and Taxation Minister, Punjab	: Member
(l) Chief Secretary to Government, Punjab	: Member
(m) Principal Secretary to Government, Punjab, Department of Industries & Commerce	: Member Secretary

- 2. Powers & Functions:** - The State Board shall exercise the powers & perform functions as mentioned below:
- to review and monitor the disposal of applications made to the District Committees, Empowered Committee and the competent authority for grant of clearances;
 - to examine and review any order passed by the empowered Committee on Industrial Facilitation, in accordance with the provisions of section 18 of the Punjab Industrial Facilitation Act, 2005.
 - to grant exemption or relaxation to any existing or proposed industrial undertaking or category of industrial undertakings or cluster of undertakings from the operation of any of the provisions of this Act or rules made there under; and
 - to grant exemption or relaxation from the provisions of any other law made by the Punjab State Legislature relating to industrial development, wherein such power of exemption or relaxation is vested with the State Government.
- 3.** The orders passed by the State Board shall be final and binding on the Empowered Committee, the District Committee and the competent authority and if there is any conflict between the decision of the State Board and the Empowered Committee the decision of the State Board shall prevail.

4. The Board shall meet as and when required.
